General Awards Criteria

- Recipient must have demonstrated personal excellence in their business or profession by conducting an ethical, profitable business.
- They must also have shown dedication to the community and to the Chamber by giving time, energy and resources.
- They must be a member in good standing of the Central Mass South Chamber of Commerce (except Citizen of the Year recipient).
- Board members currently in office are NOT eligible.

Specific Awards

Business Person of the Year

Presented to an outstanding business person in the communities served by the Central Massachusetts South Chamber of Commerce. They must meet the general criteria listed above.

Chamber Volunteer of the Year

Awarded to an outstanding volunteer who has shown a consistent individual contribution through recruiting volunteers for Chamber projects, donating time to Chamber activities, events, projects, committees, and is a model representative of the Central Mass South Chamber of Commerce.

Citizen of the Year

This award was created to recognize individuals who have demonstrated leadership in community projects and organizations and are involved in the betterment of the community through active civic participation. They must live or work within the Central Mass South Chamber's service area and be active in more than one organization. They must have community involvement beyond professional obligations. Salaried- elected officials are NOT eligible.

- Nominees will have demonstrated leadership in communities served by the Central Massachusetts South Chamber of Commerce.
- Their involvement should contribute to the quality of life in our community. As a result, nominees should have noteworthy accomplishments.
- Nominees must have assisted in business and community projects by participating in projects or events that aid in the betterment of the community.
- Nominee may not have previously won this award.
- Deadline for Nominations is September 15, 2010 and the award will be presented at the Chamber's Annual Meeting in November.
